And, rates for Unlicensed Relatives were increased on September 1, 2020 and will be increased again on August 1, 2021 to adjust for minimum wage increase in Connecticut. In addition, from COVID Recovery ARPA funding, Accredited Center-based Care 4 Kids providers will receive a 20% Quality Bonus effective for payments made on or after June 1, 2021.
