- The CAN that gets assigned to the reallotted funds, which will cover the reallotments of returned FFY 2022 funds.
- 1.4 FFY 2023 LIHEAP Infrastructure Act funds include grant awards ending in LIEI. They were awarded under CAN number G992605.
- 1.5 FFY 2023 supplemental funds include grant awards ending in LIEE. They were awarded under the following Common Accounting Numbers (CANs):
 - CAN G991606, which covers the \$1 billion of emergency supplemental funding that was appropriated through Pub. L. 117-180.
 - CAN G993135, which covers the \$1 billion of disaster supplemental funding that was appropriated through Pub. L. 117-328.

You must, on the respective lines, report the funds from these sources that you expect not to obligate by September 30, 2023.

1.6 The total projected unobligated balance consists of the sum of Lines 1.3, 1.4, and 1.5. OLDC automatically calculates this amount.

Any amount on Line 1.6 exceeding the amount on Line 1.2 must be returned to HHS. OLDC shows the overall amount of these funds that you must return on the **Reallotment Amount** line. HHS will reallocate these funds to LIHEAP grantees in FFY 2024.

Due Dates and Estimates

Your estimated FFY 2023 Carryover and Reallotment Report is due by September 29, 2023, via the **Grant Solutions/On-Line Data Collection System (OLDC)**. If your estimates need to be updated, you must submit a revised, final report by December 29, 2023. ACF will accept adjustments after this date, if necessary, but all updates will be known and reported to us by the December 29, 2023, deadline, reconciling amounts reported in the FFY 2023 Standard Form (SF) 425 reports. Grantees must take reasonable steps to mitigate the risk of returned federal LIHEAP funding well beyond this timeframe.
