Figure S-1. Collecting Regular On-Time Payments

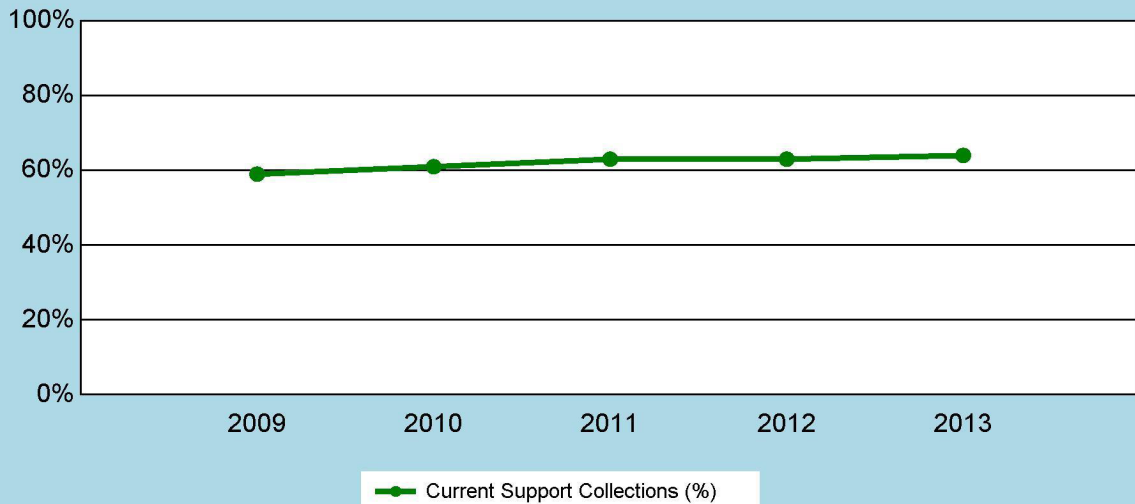

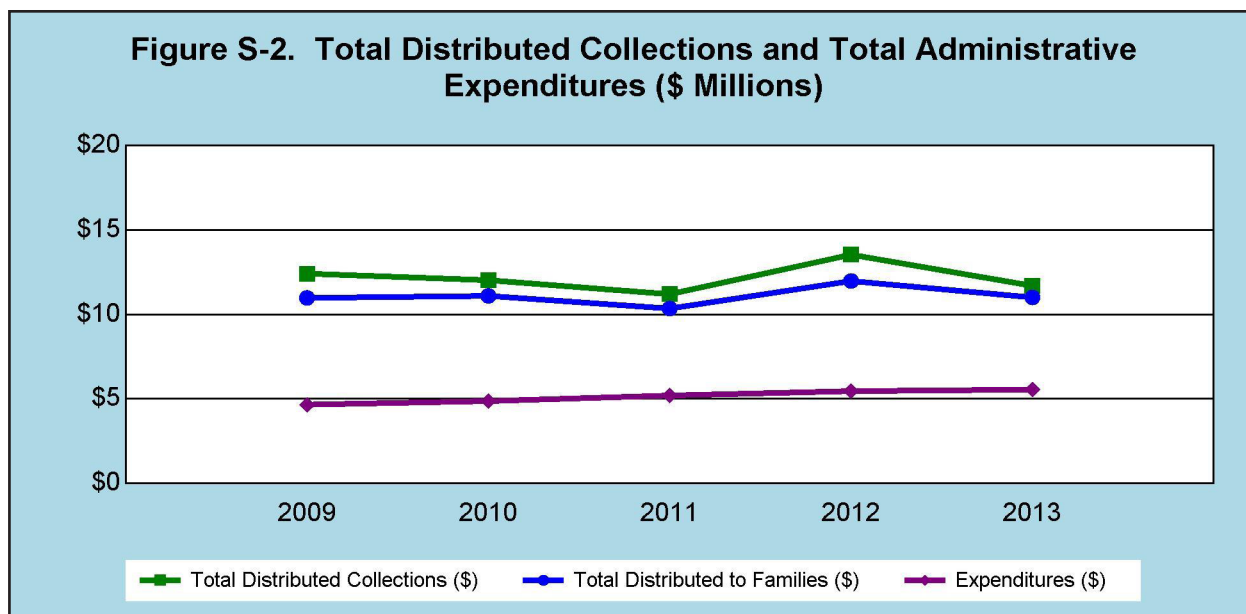


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

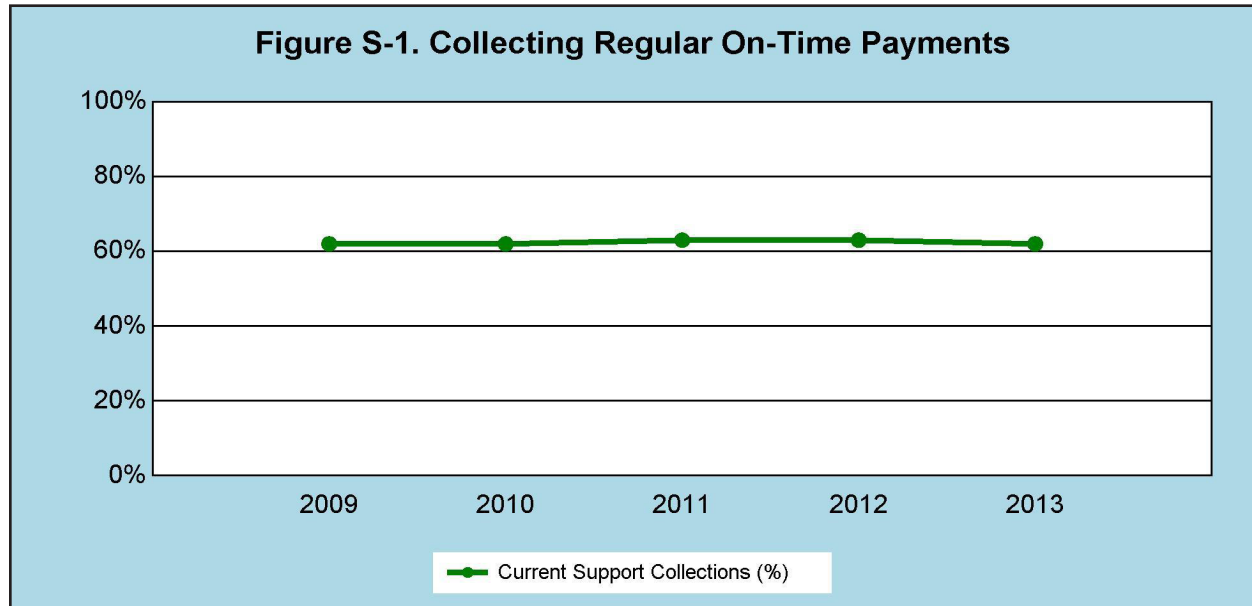


Figure S-1. Collecting Regular On-Time Payments

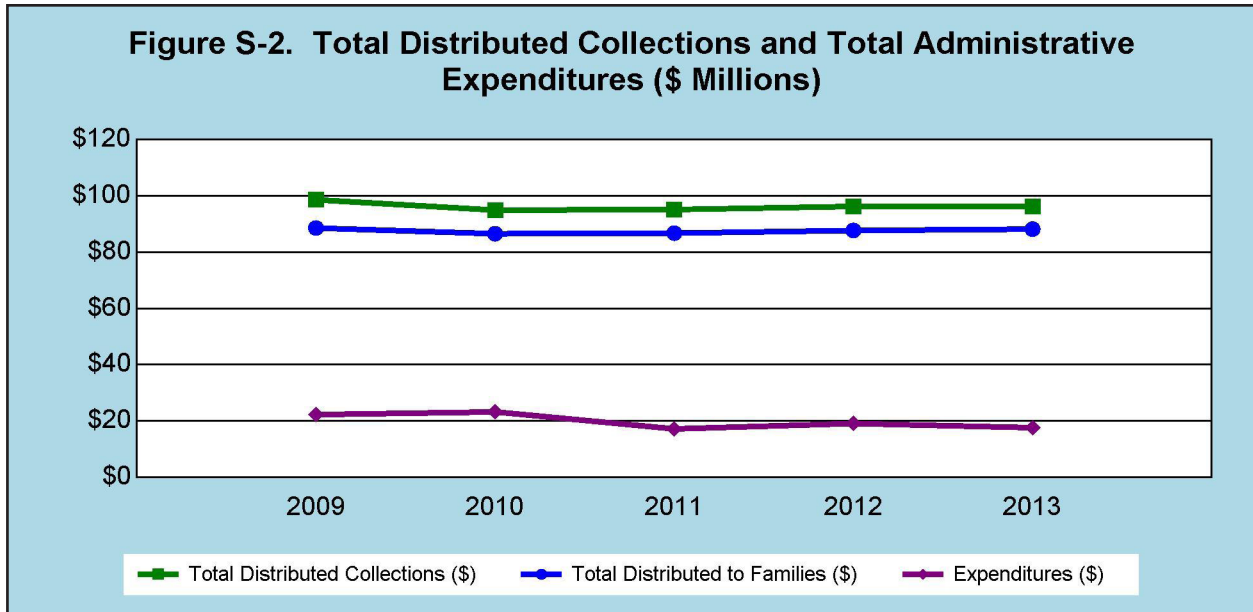


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

Figure S-1. Collecting Regular On-Time Payments

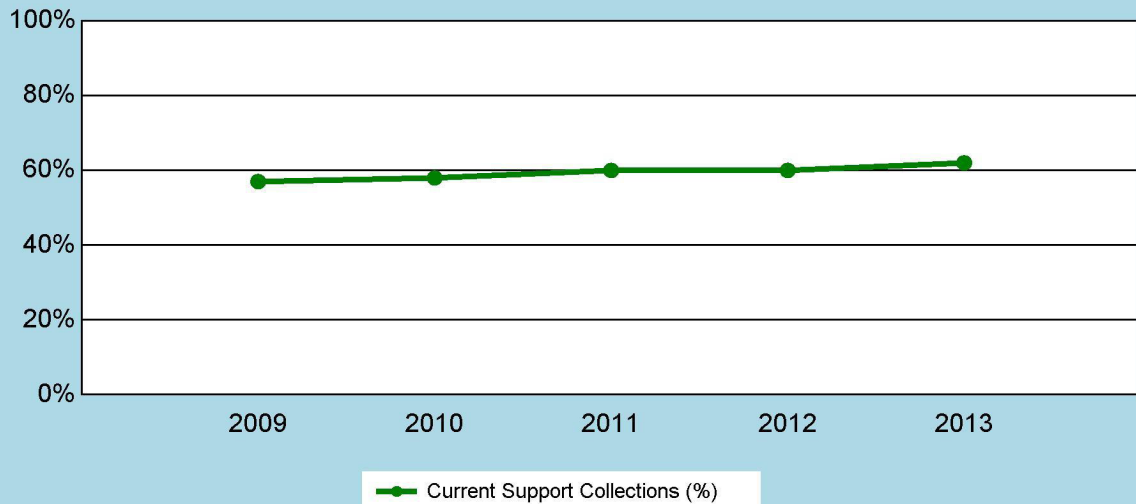

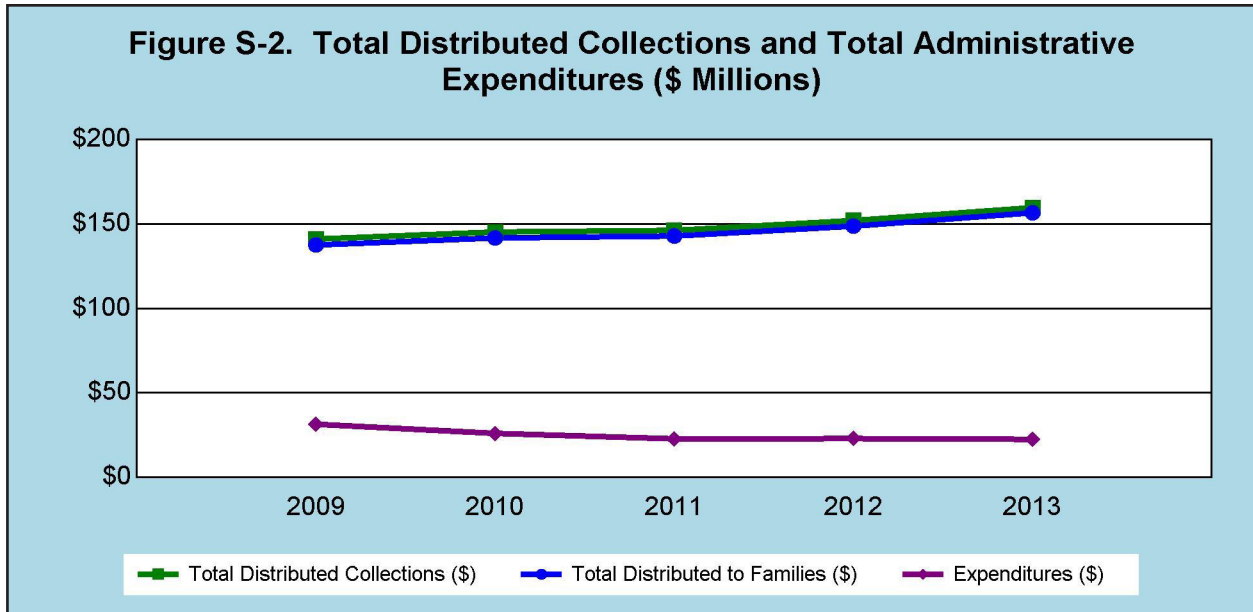


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

Figure S-1. Collecting Regular On-Time Payments

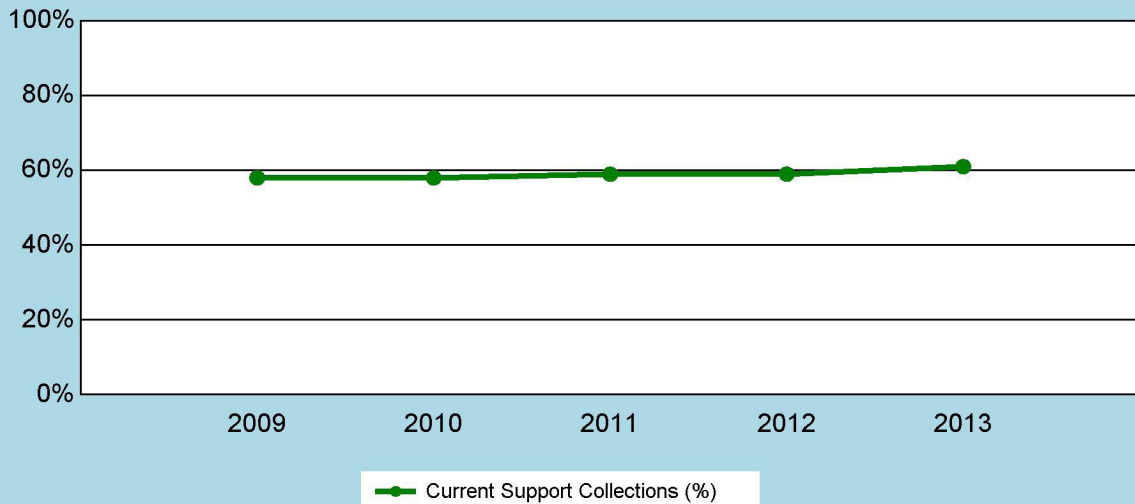

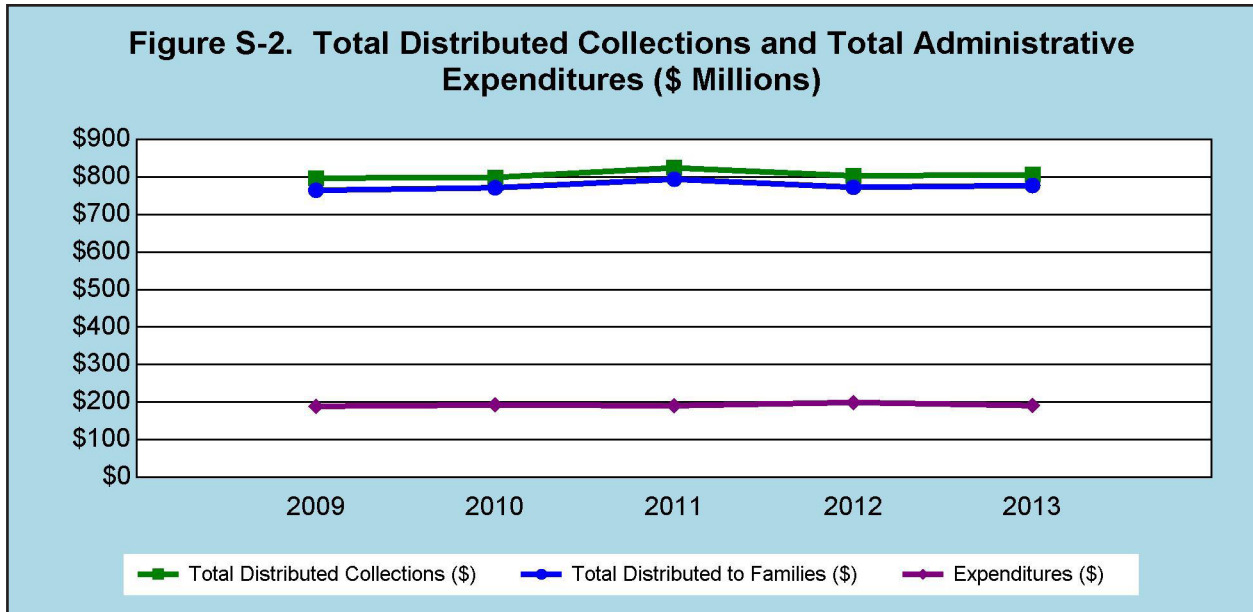


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

Figure S-1. Collecting Regular On-Time Payments

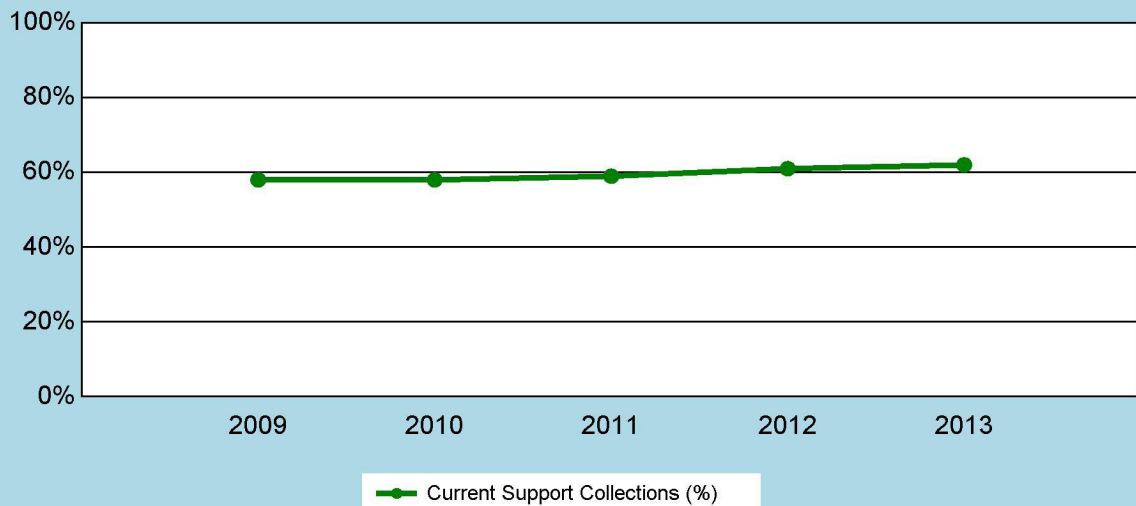

Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

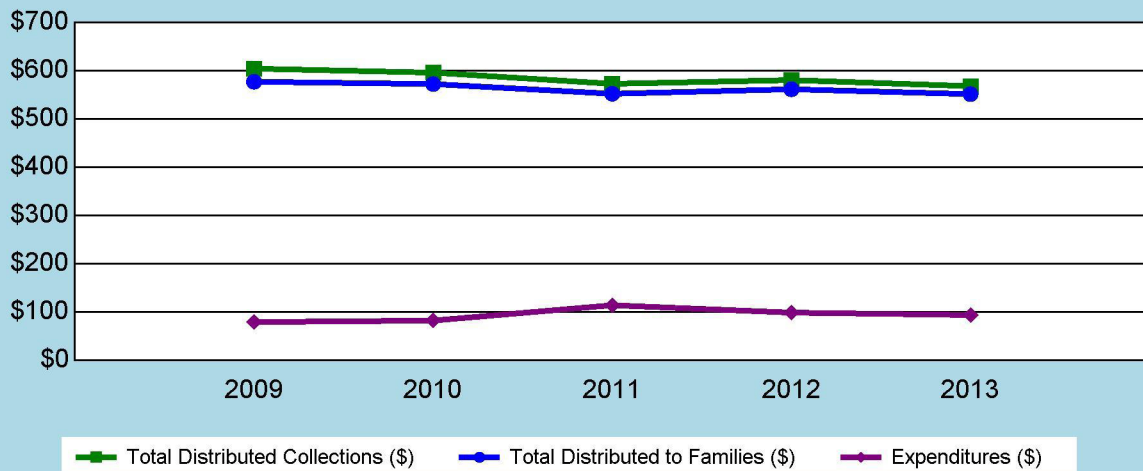


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

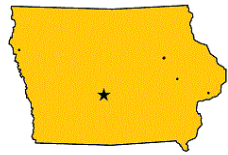

Figure S-1. Collecting Regular On-Time Payments

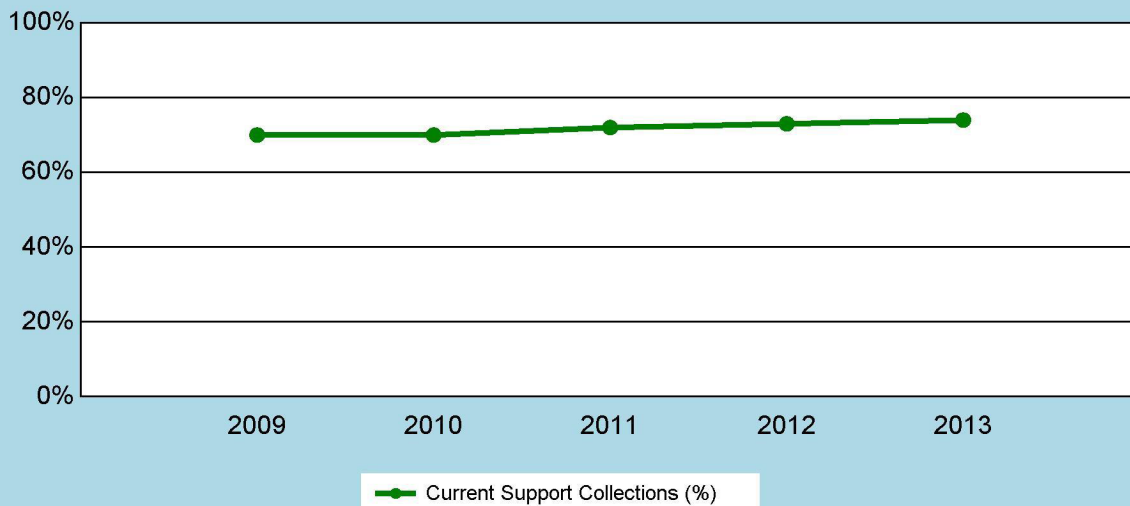

Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

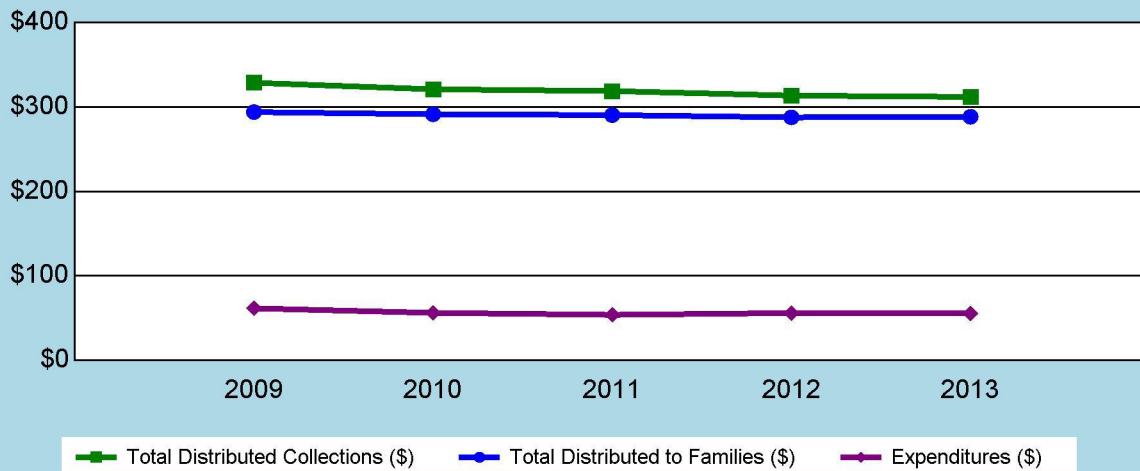


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

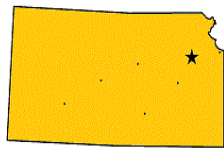

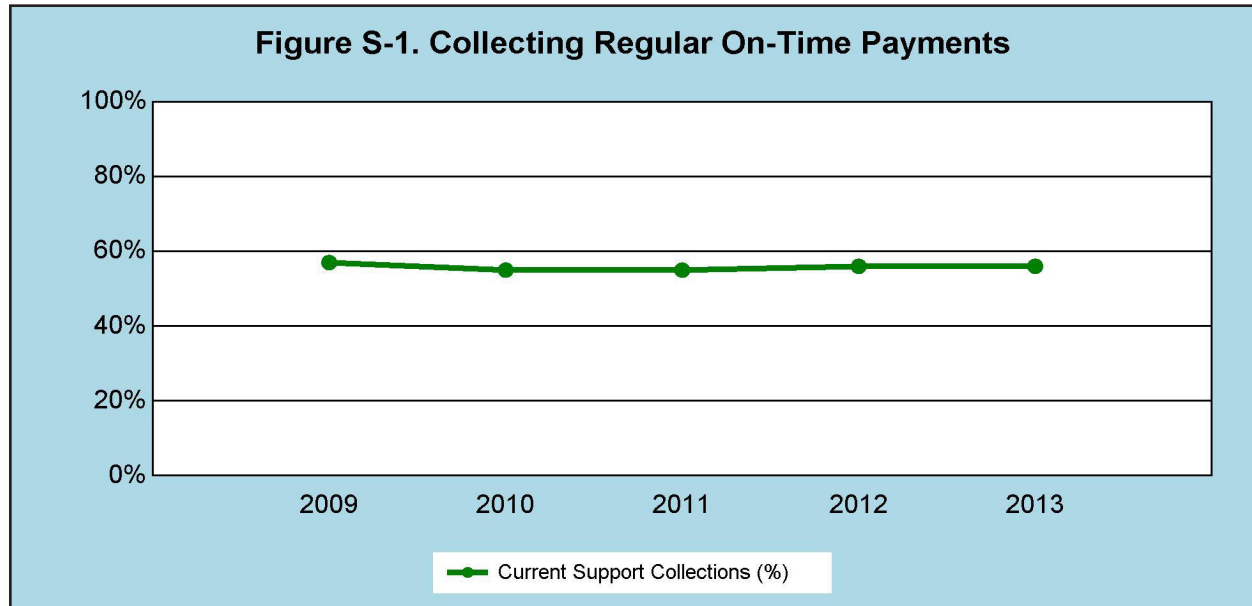


Figure S-1. Collecting Regular On-Time Payments

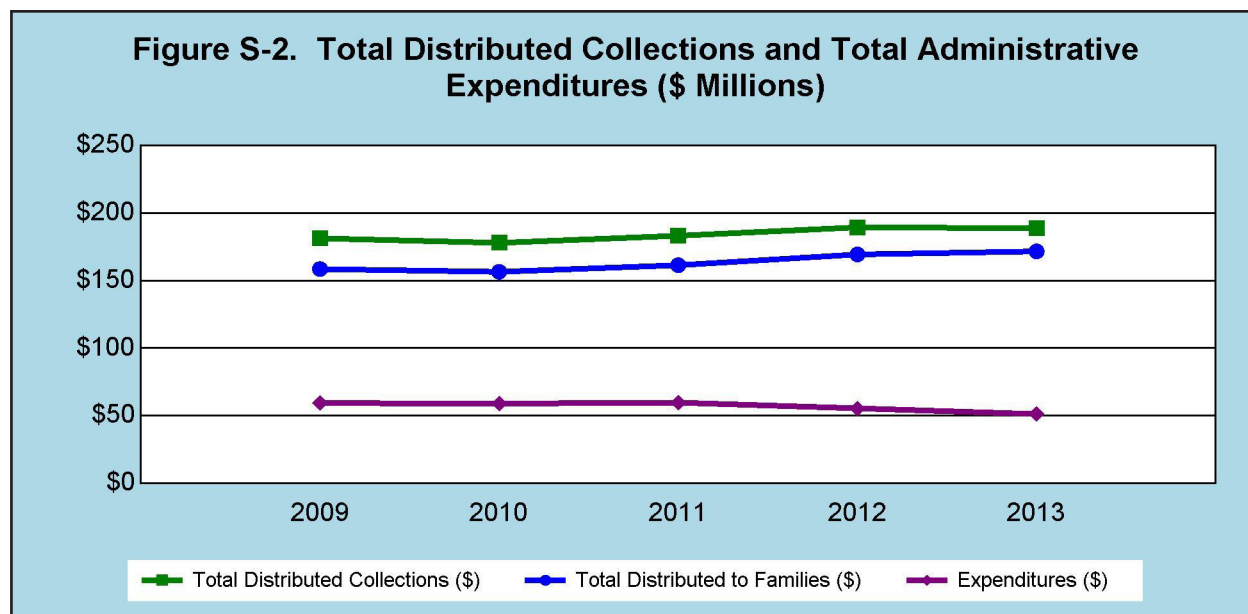


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

Figure S-1. Collecting Regular On-Time Payments

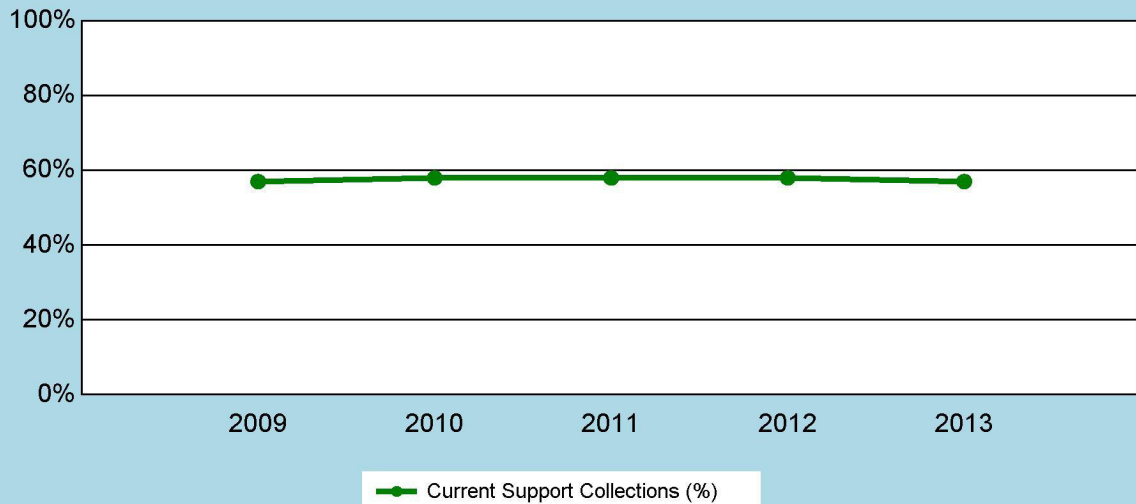

Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

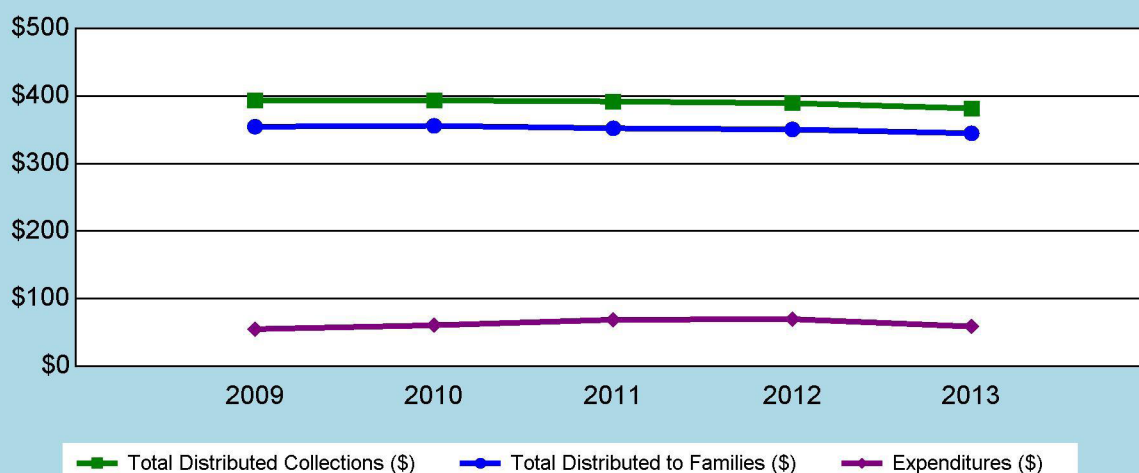

Figure S-1. Collecting Regular On-Time Payments

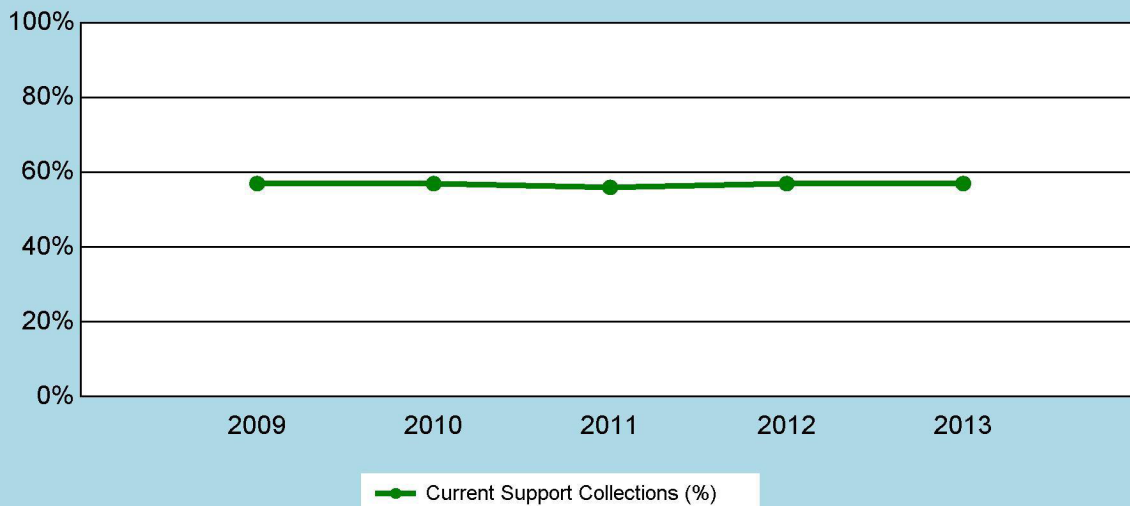

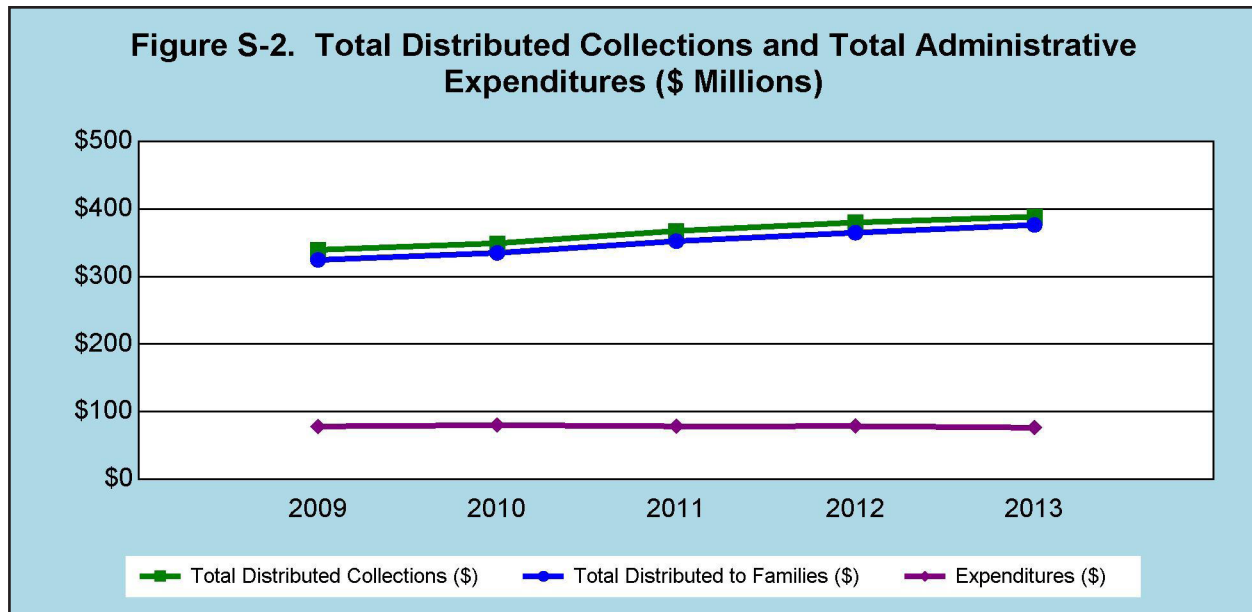


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

Figure S-1. Collecting Regular On-Time Payments

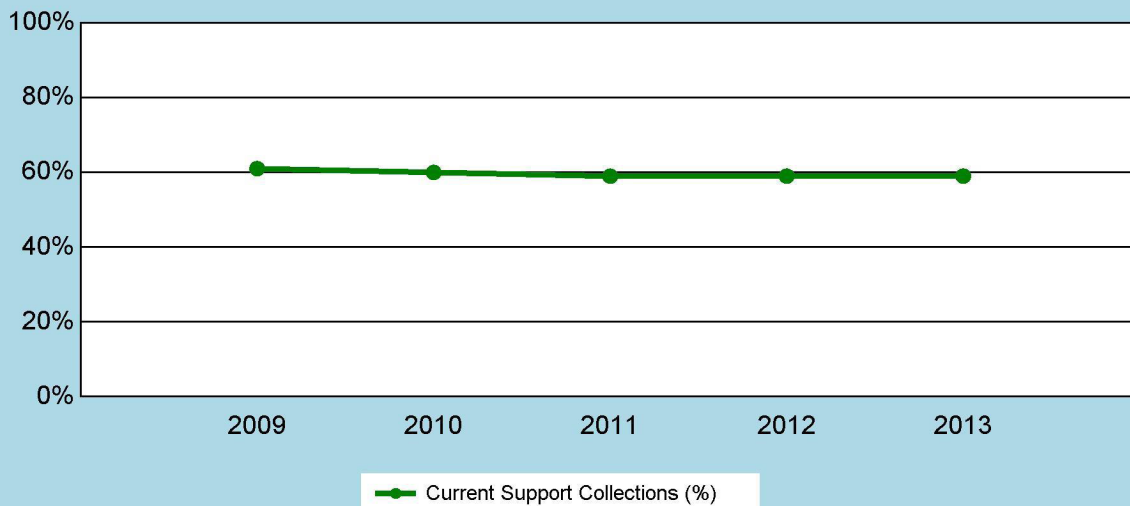

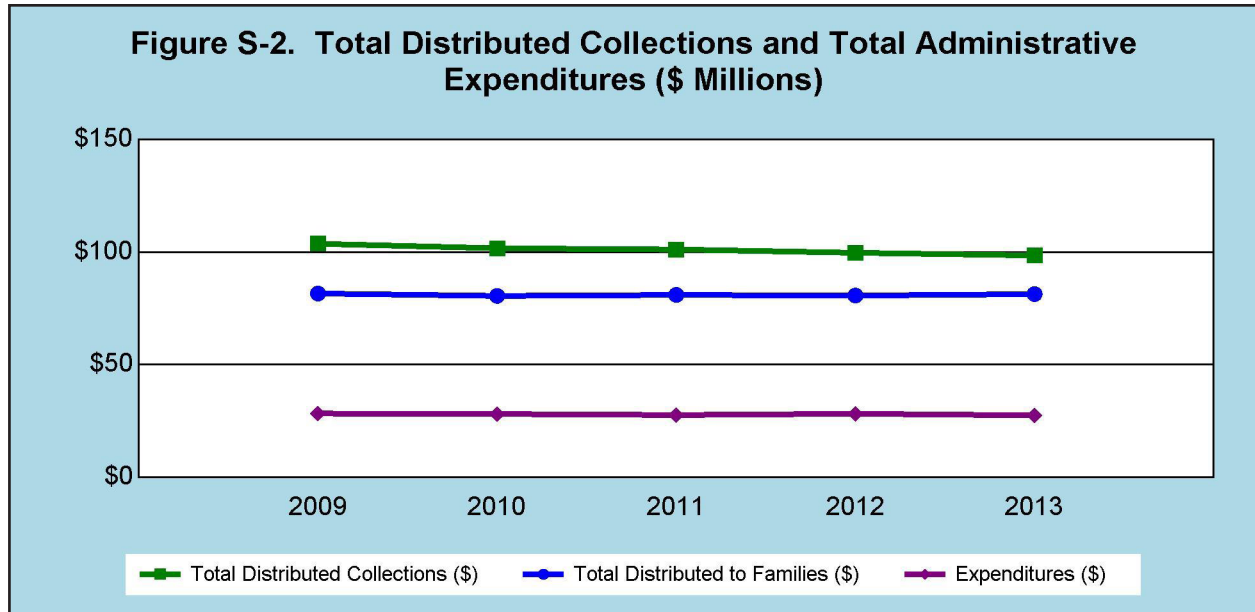
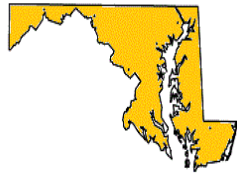


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)

Figure S-1. Collecting Regular On-Time Payments

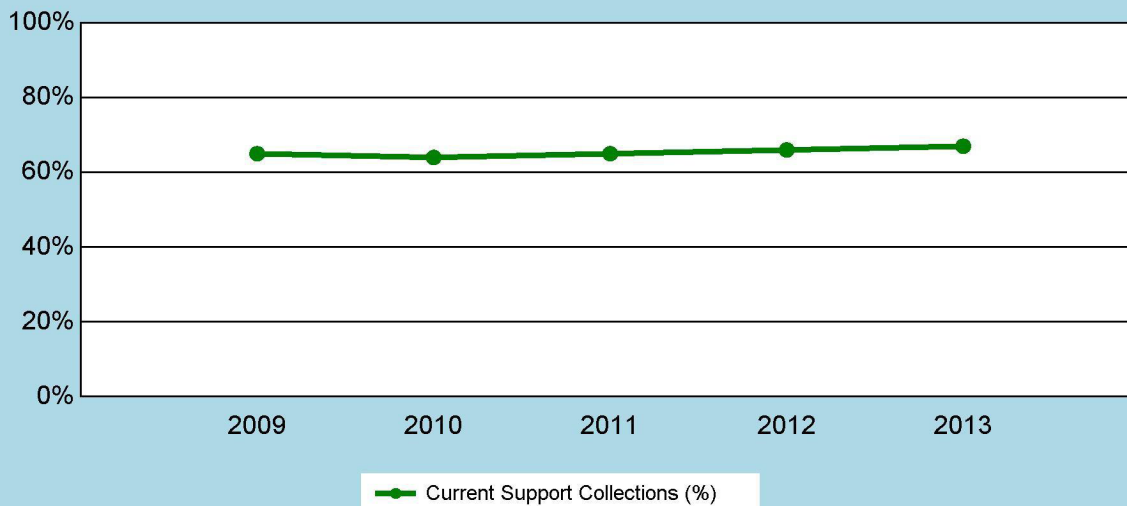

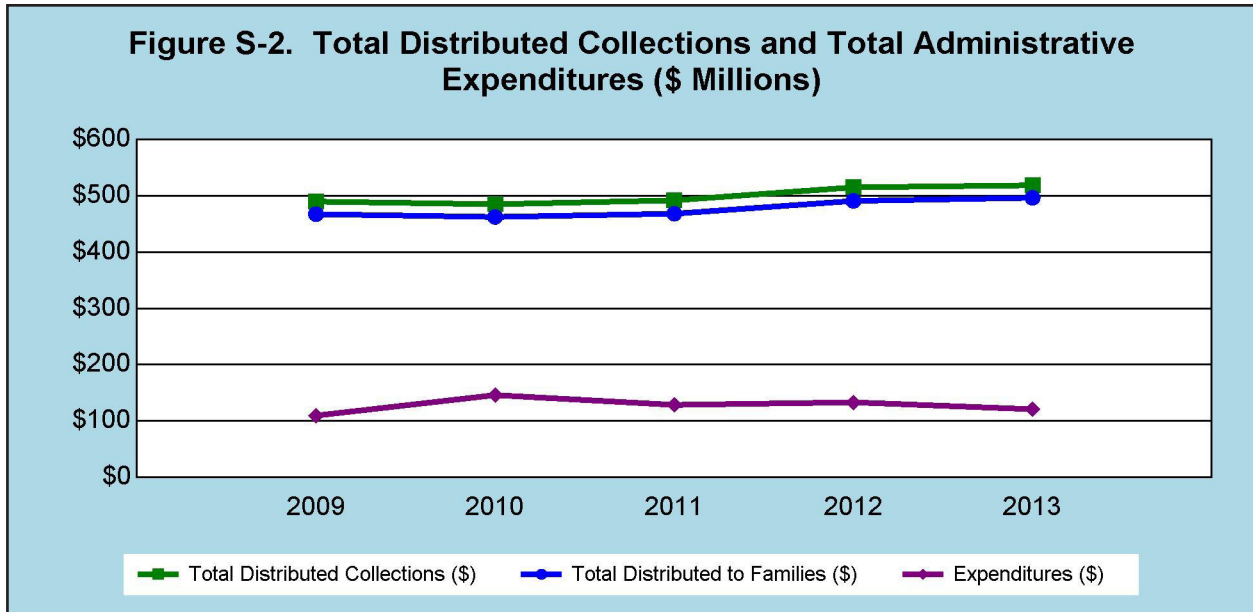


Figure S-2. Total Distributed Collections and Total Administrative Expenditures (\$ Millions)
