

## **Replacement Designee Selections for Fiscal Year 2022**

Dear Colleague Letter 22-02

Dear Colleague:

ORR is pleased to announce that selections have been made for entities to serve as Replacement Designees (RD) beginning in FY 2022 through FY 2026.

## Authority

Pursuant to 45 C.F.R. § 400.301, when a state government partially or fully withdraws from the administration of the Refugee Resettlement Program (RRP), ORR can designate one or more RDs to administer the provision of assistance and services in that state.

## **Background**

Since 2008, ORR has used its authority to designate one or more RDs for every state government that has partially or fully withdrawn from the administration of the RRP. As noted in ORR <u>Dear Colleague</u> <u>Letter (DCL) 21-07</u>, while ORR may designate an RD whenever necessary, ORR intends to compete the role of RD in each state for which a RD is designated, every five years, in order to ensure a fair and transparent process. ORR announced the first competition in 2021, and the following entities have been selected to administer all or part of the RRP beginning in FY 2022:
