Layout Explanations

- **VA File Number**

- **Note:** If 8 position VA File Number is used, last position will be a space.

- **Date Fields**

Note that dates in the state input\return output portion of the file are formatted differently than dates in the VA VETSNET portion of the file. Also, date formats are changed from the previous VA file match with BDN.

- **Entitlement Codes**

The entitlement codes have not changed. They likely will be limited to the following (although older non-active records are possible):

First Position

- 0 - Gulf War Service
- 1 - WWI Service
- 2 - WWII Service
- 3 - Korean Conflict Service
- 4 - Peacetime Service
- 7 - Vietnam Service
- 9 - Philippine Service

Second Position

- 1 - Compensation
- 2 - Protected Pension (veteran)
- 4 - Section 306 Pension (veteran)
- 5 - Death Compensation
- 6 - Protected Pension (survivor)
- 7 - Dependency Indemnity Compensation
- 8 - Section 306 Pension (survivor)
- D - Improved Pension (survivor)
- L - Improved Pension (veteran)

- **Amount Fields**

Amounts are currency and are displayed in whole dollars (no cents). This is a change from the previous VA file match with BDN that had included cents.

- **Fiduciary**

If a co-fiduciary existed, the extract will only include the first name listed for fiduciary.

- **Filler**

Included extra characters in case of any future expansion to the data fields.
